## **PRINCIPAL ACCOUNTABILITIES/RESPONSIBILITIES:**

#### SETTER

Lock off/Tag off procedure to be followed whilst setting/changing dies

Safety harness is in good working order

>Any platforms/Ladders/anchor points are not damaged or dirty

>Safe working at height

>Prepare the area for setting/changing dies

>Preparation of the dies in the green area to the set up & check sheets

>Working with the SMED teamwork towards improving changeover times
